## RV Product Limited Warranty

### Introduction

Mabru Power Systems Inc. is referred to as “Mabru”.

Mabru’s *Recreational Vehicle (RV) Product Limited Warranty* covers all air conditioning units sold by Mabru targeted for the recreational vehicle (RV) market. The Mabru RV Product Limited Warranty is defined herein and is referred to as “Limited Warranty” or “The Limited Warranty”.

The Limited Warranty is transferred from the RV Dealer to the original purchaser, who is referred to as “Original Owner,” upon final sale. If a recreational vehicle housing a Mabru RV Product is resold, the Limited Warranty passes to the “Subsequent Owner”. The term “Owner” is used interchangeably herein. The Limited Warranty provided by Mabru applies to the Owner of a Mabru-manufactured RV product. This Limited Warranty covers Mabru Products' defects in material that have operated under normal use after proper installation.

### Coverage

If Mabru, at its discretion, determines that a Mabru Product is defective within the applicable Warranty Period specified in the Warranty Period Section, Mabru shall either repair or replace the Mabru Product or refund the original purchase price. The labor charges for removal, reinstallation, and/or repair are the Owner’s responsibility. The Limited Warranty does not cover travel time for the service dealer; any travel time will be the Owner's responsibility.

This Limited Warranty supersedes all other express warranties and liabilities. A cash refund constitutes full and final satisfaction of all claims. Implied warranties, including those of merchantability and fitness for a particular purpose, are limited to the duration of this

Limited Warranty. This Limited Warranty provides specific legal rights, and the Owner may have additional rights depending on their jurisdiction.

Mabru provides a 1-year parts only, limited warranty on all RV rooftop air conditioners. Labor is not included.

## Warranty Coverage Period

### **Original Equipment Installation:**

If your Mabru unit was installed as original equipment on a new vehicle, warranty coverage begins on the date of the recreational vehicle's original purchase.

### **Aftermarket Purchase:**

For Mabru Products purchased separately (not as original recreational vehicle equipment), coverage begins on the date of the product purchase.

To confirm warranty eligibility, the Owner must provide valid proof of purchase (such as a dated sales receipt or recreational vehicle purchase documents) at the time of filing a claim.

## Inclusions

Repair or replacement of defective parts.

Replacements and exchanges may be made using new, remanufactured, or refurbished parts, at the discretion of Mabru.

## Exclusions

This Limited RV Product Warranty does not cover damages or failures caused by:

- Mishandling or neglect
